Since 2007, Jewish Family Services (JFS) has hosted community programs on mental health issues with the goal of increasing awareness of mental wellness, decreasing stigma, and helping to create a caring and inclusive community which welcomes and supports people with mental illness and their families.

Past programs such as “The Many Faces of Depression: Hope and Health” featuring Olympian Suzy Favor Hamilton, “Tough Guise” by Jackson Katz, and “Compassion Fatigue” by Mary Jo Barrett have offered education and professional development resources to individuals impacted by mental health challenges, their families and caregivers, mental health and primary health care providers, advocates, and social workers.

Today, the Hirsh Larkey Mental Health Conference has earned a reputation as an excellent local resource for community outreach and education focused on mental health issues. In May 2017, the conference featured a three hour seminar, “Real Men, Real Stories”, led by key note speaker Mark Meier, Executive Director and Founder of Face IT with panelists Bill Dehkes, Dan Foley, and Michael Atkinson to address depression and healing from the male perspective. Attendees learned how to recognize the hidden warning signs of depression, gained a better awareness of the challenges men face in coping and seeking treatment and finally, learned more about innovative and nontraditional treatment options that support successful recovery.

Celebrating 150 Years of Hope, Help, and Healing in Our Community



Lerner Family

In September of 1867, the founders of Jewish Family Services (JFS) held their first formal business meeting to launch a special society to meet the urgent needs of the local Jewish community. JFS is one of the longest standing Jewish-based organizations and one of the oldest incorporated organizations in Wisconsin.

In October of 2017, we kicked off our 150th Anniversary celebration at our annual meeting held at Congregation Emanu-El

Here are a few of our remarkable accomplishments during our 150 year history:

1867

The Jewish community organizes the Hebrew Relief Society. With no paid staff and a budget of only a few hundred dollars, funds are raised through dues, fund solicitations and charity balls.

1902

The Hebrew Relief Association helps organize The Federated Jewish Charities (now the Milwaukee Jewish Federation).

1889

The Hebrew Relief Society is renamed The Hebrew Relief Association and expands its mission to assist and integrate many Jewish refugees from Russia and other European Countries.

1919-1920

The Hebrew Relief Association helps organize the Society for the Care of Dependent Jewish Children. Concerns about the lack of medical care led to the establishment of medical services in the Outpatient Department at Mt. Sinai Hospital and the Sol Fein Memorial Dental Clinic.



1926

Establishes the Abraham Lincoln House as the first nursery school that became the nucleus of the present UWM Nursery School and Day Care Center.

1937

The Great Depression necessitates new vocational programs that later become Jewish Vocational Services (JVS). A Self-Help Fund assists the unemployed and immigrants to establish their own small businesses.

1948

Services expand to children through a merger with Milwaukee Jewish Children's Home and a new agency name of Jewish Family & Children's Services.

2002

Opening of the Jackson Street Child Development Center to care for nine children ages six weeks to five years.





B'ne Jesurun. Past President, Howard Sosoff, opened the event with a warm welcome and past JFS President and CEO, Sylvan Leabman, spoke about JFS' transformation over the years, with special recognition given to all of JFS' past leaders. Honored guests included Maury Schechtman and Lenore Picus who lived in JFS' Children's Home and spoke of fond memories and affection for Ethyl and Phil Barnett, who operated the home. Bob and Mary Lerner shared their personal story of adopting their son, Ben, who was the last child adopted from JFS' orphanage.

150th Anniversary Taskforce Co-Chairs, Bonnie Bockl Joseph and Marlene Lauwasser made the exciting announcement of our \$1.5 million campaign to raise funds to support access to services, investment and capital improvements in affordable housing, and to build our endowment for the long-term sustainability of JFS. Milwaukee County Circuit Court Judge Mary Triggiano wrapped up the evening with a keynote address on Adverse Childhood Experiences (ACE) and the importance of JFS' clinical focus on trauma informed care.

2007

JFS Celebrates 140 years of service and honors past Presidents and former Executive Vice President Elliot Lubar for their Leadership, Legends and Legacies. Bart Starr delivers his keynote address to over 450 guests.



2008-2009

JFS received \$10.4 million in Affordable Housing Section 42 tax credits from the Wisconsin Housing and Economic Development Authority (WHEDA) to start construction on Deerwood Crossing, a 66 unit affordable housing apartment building for seniors.



2010

JFS received tax credits from the Wisconsin Housing and Economic Development Authority (WHEDA) to fund Bradley Crossing, a 114-unit affordable apartment building for individuals with and without disabilities. The result was a model apartment complex that promotes independence and integration for individuals requiring support services and other forms of assistance.

2013-2014

The clinic added Nativity Jesuit Middle School, to our in-school counseling program. JFS is one of the first agencies in Southeast Wisconsin that has licensed clinicians on site at schools. In addition to Nativity, JFS also served clients at Central City Cyberschool and the Brown Deer School District.



2016-2017

JFS partners with Sojourner Family Peace Center as a co-located agency to provide mental health and trauma-related counseling services to survivors of sexual assault and domestic violence.




JFS FY 2017 CLIENT DEMOGRAPHICS



School-Based Counseling: Breaking Down Barriers to Care

Jewish Family Services (JFS) was one of the first outpatient mental health service providers to improve access to counseling services for children by locating clinicians in a school setting. Our School-Based Mental Health (SBMH) program improves students' mental health and prosocial behavior while addressing symptoms of stress and trauma, such as peer relationship problems, conduct issues, or emotional instability. JFS provides services in the Brown Deer School District and at Central City Cyberschool. Children who are identified by teachers, other staff or parents as needing mental health services are enrolled in one-to-one counseling sessions that occur during the school day. Locating services in the school leads to greater participation because children don't have to travel or make changes to their daily routine. As a model, school-based counseling is shown to be more effective than counseling offered in traditional settings. According to the School Based Health Alliance, barriers experienced in traditional mental health settings—stigma, non-compliance, inadequate access—are overcome in school-based settings and students served in schools had fewer discipline problems, course failures, and school absences. When a student in counseling shows improvement, other students in the school environment are less impacted by a struggling student's classroom behavior, teachers can focus on education rather than behavioral issues, and families receive much needed support in understanding and helping their child manage his or her problems.

Many of the children who participate in school-based counseling experience behavior problems and/or mental health disorders as a result of chronic stress, trauma, and/or depression. Students with significant personal trauma benefit from our clinicians' expertise in Trauma Informed Care (TIC) that addresses the potentially long term negative impact of Adverse Childhood Experiences (ACE). The Centers for Disease Control and Prevention (CDC) reports that mental health problems are far more common among individuals living in poverty. In Wisconsin, 22% of poor children, and less than 9% of children in wealthier homes experience mental health issues. More than half our clients this school year are living in extreme poverty, with annual family income below \$10,000.


Our collaborative therapeutic process maximizes engagement with the student, their parents and teachers. It also improves awareness of the mental health challenges faced by children and reduces the stigma associated with treatment. We are able to provide school-based counseling through a combination of insurance reimbursement and philanthropic support. We thank the Milwaukee Brewers Community Foundation and the Gene and Ruth Posner Foundation for their support of this program.

Support Services for Individuals with Disabilities

Our Disabilities Case Management (DCM) program serves individuals with developmental and intellectual disabilities and chronic mental illness with a focus on collaborative, client-centered treatment planning, independent living skills, financial support, and assistance with decision-making. We help clients reduce personal isolation and overcome stigma associated with having a disability through socialization activities that promote building relationships and a sense of community with others.

Nine years ago, a distraught mother brought her adult son, Juan, to JFS, desperate for help. She had lovingly adopted him and his little sister from an orphanage in Columbia when he was six years old. It was apparent that he had suffered abuse in early childhood and, as he matured, his situation worsened. During his teenage years he affiliated with gangs and by the time we met him (in his mid-twenties), he was living in very unstable housing – couch-surfing among various associates – and suffering from serious physical and mental health issues.

In addition to obvious and serious mental health issues, Juan has many complex and debilitating physical ailments, including Polymyositis (an uncommon inflammatory disease that causes muscle weakness) and Rheumatoid Arthritis. Amazingly, despite this, his first attempt to file for disability coverage was denied. JFS secured an attorney to appeal the decision and provided financial assistance which allowed for a secure living situation over the nearly two years it took for the appeal to be successfully completed.

Now 36 years old, he is truly a success story. He is a reliable employee who takes great pride in his work at a local restaurant (25 hours per week). He has been recognized by the ownership for the high quality work he does behind the scenes at the restaurant. (Once, while he was absent for a period of time, they received complaints from customers that the food tasted different, and attributed it to his absence.) He is an active member of his church, attending twice weekly. He has a group of friends and participates in social outings such as JFS’ Sandy Naimon Breakfast Club, and a monthly men’s group organized by his remarkably committed psychiatrist, Dr. Longo (Aurora Health). He has a strong sense of personal responsibility, demonstrated when he repaid back JFS for the financial support he received during the lengthy appeal process.

Despite his apparent capabilities, Juan’s life remains full of challenges that are unimaginable to most people. At 36, he experiences medical challenges of someone decades older; he has had a knee replacement, foot surgery, and routinely sees specialty care doctors. Recently, a case of the chicken pox resulted in a three-day hospital stay because of the risk it posed to his compromised immune system. His JFS case manager handles the complex logistics of scheduling and transporting him to appointments so that he is able to maintain his employment.

Juan’s story shows how coordinated care can transform an unstable life into a very productive and fulfilling one. In his words, “I have learned of services that can help me and not to be ashamed of my illness. I know when to ask for help when I feel uncertain of my life. When I felt there was no hope for me, I was reassured that there is, was, and will be a purpose for my being here. JFS has taught me to stand up and hold my chin up like when I made my first soccer goal as a kid.”

A Place to Call Home

As a trusted social service provider for the last 150 years, we know firsthand that individuals with disabilities, especially those with chronic mental health issues, seniors, and low income families face many challenges in securing safe and affordable housing and receiving specialized support services that promote full inclusion, housing stability, and a better quality of life. Despite the requirements of the American with Disabilities Act and the Fair Housing Act, individuals with disabilities and low income families experience high levels of discrimination in choosing where they want to live. In 2009, Jewish Family Services took action to address the urgent community need for safe and affordable housing for all persons. This vision led to the opening of Deerwood Crossing Senior Residences, Bradley Crossing, and the Harry and Jeanette Weinberg Residences at Bradley Crossing. Our service model has been highly effective in promoting a welcoming and inclusive residential environment in which adults and children with and without disabilities can live together, develop meaningful relationships, and build a strong sense of community without stigma, fear of discrimination, isolation, or vulnerability. This model of successful integrated housing serves as a highly visible example to the community of affordable, accessible, quality living options that allow individuals with disabilities to remain anchored in communities with which they are familiar. In total, nearly 350 residents call our residential community “home”.

Leveraging Technology to Achieve Quality Care

In the spring of 2017, Deerwood Crossing Senior Residences implemented a web-based electronic health records system specifically designed for assisted living and senior care communities. The software features electronic medical administration record (eMAR) capabilities that provide alerts to staff to ensure medications are administered on time and according to a resident’s care plan. Nursing staff is able to easily monitor the medication inventory with real-time notifications and reorder via the software’s integration with Deerwood’s pharmaceutical provider. The software also allows resident aides to track care management tasks. It also creates and stores patient health assessments, generates care plans, provides electronic charting and assists with state-mandated reports.

Daniel Fleischman, VP of Housing and Residential Programs says, “This new system allows the entire care team to instantly access and update vital information on each resident. Our previous paper-based system was cumbersome and inefficient. If we need to access information for a physician or hospital about someone’s medications, we can do so with the push of a button. Because we can document residents’ care needs directly into the system, we no longer rely on daily hard copy logs to share pertinent care information. This improves our level of communication and improves the quality of care.”



Several years ago when Karen and Jim Strom established two Memorial Endowment funds at JFS, they did so with two goals in mind: (1) To honor the memory of Karen's parents (David and Dorothy Frindell) and sister and brother-in-law (Dr. Rhoda and Edward Green), and, (2) to help the community in a meaningful way, both now and in the future. So they created funds that reflected the interests of these loved ones, namely: The David and Dorothy Frindell Memorial Endowment for the Elderly, and the Dr. Rhoda and Edward Green Memorial Merit Scholarship Fund for JFS Staff Advanced Education. They envisioned these custom-designed funds continuing the charitable ambitions of their loved ones for years to come.

Dave and Dorothy had always been champions of the elderly and those in need of a friend. They had married in 1931 during the heart of the depression, so knew about hard times. During the early years of their marriage, Dave opened a small sign shop, working long hours to support his wife and infant daughter. Those were lean days, and he and Dorothy often struggled to make ends meet. Because of it, they were always ready to help others. Weekly visits to aging friends and relatives were a family ritual. And helping those who struggled financially was a given. After nearly 60 years of marriage, Dave passed away in 1990 and Dorothy in 1994.

In a similar way, Rhoda and Ed had always been champions of education and advocates for learning. Her University education was helped along with scholarships and student loans, and his with the GI Bill. Initially, Rhoda became an advertising executive in the world's largest advertising agency, but went back to school and changed careers. She ultimately became a licensed business psychologist specializing in career development. For a short time, Rhoda served as a Professional Development consultant to JFS. Ed had studied education and became a school teacher. However, each acknowledged that without the financial aid they received, they probably wouldn't have

been able to afford a college education and their lives would have been much different. Rhoda passed away in 2012 and Ed in 2013 after 50 years of marriage.

With their loved ones gone, the Stroms began considering options for establishing legacy funds for them in 2016. They were well-familiar with JFS and its positive impact on the greater Milwaukee community. Their small family PR firm had been hired as a marketing resource in the 1990's by now-retired JFS CEO, Elliot Lubar. Over a span of a few years, the firm worked with JFS to develop the agency's first website and create a number of its brochures and annual reports.

"During that time, we gained insight into the workings of the agency," Karen commented. "Our firm also witnessed the profound impact JFS had on the community through its vital services – many of which had been provided since the 1920's." According to Karen, the agency's commitment to identifying community needs and filling them through comprehensive programs, a dedicated staff and teams of volunteers were very apparent.

Although neither the Stroms nor their family members personally had occasion to utilize JFS services, "All of us were well aware that they were available if needed," Karen said, adding, "That, in itself, was a great comfort..... so we decided to fund the two endowments with JFS."

In retrospect, keeping the wishes of their loved ones in mind while setting up the endowments at JFS was the start of an ongoing win-win for everyone. "From day one, these funds became a precious link from the past to the future – from generation to generation," Karen said.

A number of my clients have experienced chronic abuse and frequently dissociate as a result. This can make their lives quite challenging and often they are turned away by psychotherapists due to their complex presentations. This scholarship allowed me to attend an annual conference hosted by the International Society for the Study of Trauma and Dissociation (ISSTD). This training helps JFS fulfill our vision to reach those in most need and receive the adequate, competent and compassionate help they so truly deserve.

Home and Hope: A Community Call to Action Event Featuring Matthew Desmond, Author of *Evicted*

In May 2018, we hosted a community-wide call to action event to shine a spotlight on the epidemic of evictions and its devastating effects on low income families in our community.


The event featured a powerful keynote address by Matthew Desmond, acclaimed author of the Pulitzer Prize-winning book *Evicted – Poverty and Profit in the American City*. Based on the true life stories of individuals in our community, Matthew Desmond describes the desperate reality for families trapped in poverty, searching for hope and a place to call home. Two years after its release, *Evicted* remained at the top of the *New York Times* Best Sellers List, was recently recognized with the 2018 Stowe Prize for Writing to Advance Social Justice, and has been recommended as a “must read” by Bill Gates, President Barack Obama, and other literary critics.

We thank co-chairs, Roberta London and Olga Vaynshtok and the entire event committee for their commitment and hard work in planning such a successful event.

Following the keynote, guests were invited to attend an important community stakeholder panel discussion on the complex social and economic issues challenging our local community. Expert opinions focused on employment development, housing development, public safety, and public health. Panelists included Earl Buford, President and CEO - Employ Milwaukee, Inc., John Chisholm, Milwaukee County District Attorney, Jennifer Sevenich, CEO - Progressive Community Health Centers, and Wyman Winston, Executive Director - Wisconsin Housing and Economic Development Authority (WHEDA). Paula Penebaker, CEO - YWCA Southeastern Wisconsin, served as the panel moderator.

The event featured the exhibit: *Crossing the Line - The Milwaukee Fair Housing Marches of 1967-1968*, a traveling exhibition presented courtesy of the Wisconsin Historical Society and Boswell Book Company hosted an onsite bookstore with a special selection of books recommended for reading after *Evicted*.

“Home and Hope” was the largest special event in Jewish Family Services’ history with nearly 1,000 guests in attendance.



Staying Close to Our Roots: Social Services for the Russian Speaking Immigrant Community and Holocaust Survivors

When Jewish Family Services (JFS) opened its doors 150 years ago as the Hebrew Relief Society, meeting the urgent needs of the growing Jewish community was paramount. As a steady stream of European Jews migrated to the United States at the end of WWII, JFS established a formal resettlement network that included host families, assistance with employment, housing, medical care, orphanages, adoption services and many other programs. Since then, we have maintained our commitment to the Jewish community and the aging generations of Russian speaking individuals through culturally sensitive social services. Over 450 individuals a year receive personalized assistance with basic life needs including interpretation services at medical appointments, immigration issues, managing Social Security, Medicare, Medicaid and other government benefits, accessing healthcare services, translating documents, classes to learn English, and other essential needs. Of these clients, 206 are also eligible for the formal designation of Holocaust Survivor and as a result, receive additional assistance through the Claims Conference on Material Claims Against Germany. The vast majority of individuals served are age 75-94 and 77% have incomes under \$15,000.



In 2017, JFS partnered with the Alpha Omega-Henry Schein Cares (AO-HSC) Holocaust Survivors Oral Health Program to facilitate applications for free dental work to Holocaust survivors in the greater Milwaukee Area. Since 2015, this program has provided hundreds of Holocaust survivors across the United States with free oral care services. Because Medicare does not cover dental services, many of our clients are often uninsured or underinsured and cannot access the most basic oral health care. Priority was given to eligible persons based on the need to eliminate painful oral conditions, restoration of function, and lack of dental insurance coverage. All of the survivors served through the AO-HSC Holocaust Survivors Oral Health Program have benefited greatly from free access quality oral health care, which is often neglected due to a lack of insurance and ability to pay.



Edna’s Story: Why Safe and Affordable Housing Matters Most

It has been almost 10 years since Jewish Family Services (JFS) took action to address the urgent community need for safe and affordable housing for some of the most vulnerable persons in Milwaukee, including persons with disabilities, seniors, and low-income families. This vision of accessible integrated housing led JFS to develop Deerwood Crossing Senior Residences and Bradley Crossing Supportive Housing Community in the Village of Brown Deer.

Recently, journalist James Causey did a story in the *Milwaukee Journal Sentinel* on one of our residents, Edna. She shared that before moving to Bradley Crossing, she and her grandchildren had to take cover when they heard gunshots and her landlord entered her apartment anytime day or night with no notice. Edna felt trapped because she could not afford higher rent and with evictions on her record, she would never be given the chance to live in a better environment. The company of rats and having no hot water were the norm. The stress was overwhelming, she became depressed and her physical health suffered. She confessed that she felt like she was having a nervous breakdown and ended up checking herself into a hospital. She received a whole host of diagnoses but the strongest prescription she was given was that she should move out of the awful place she lived in.

Today, what Edna says about her experience living at Bradley Crossing speaks to the power of safe, affordable, and supported housing. She says, “Bradley Crossing saved my life. Living out here is really night and day. . . . I can take walks when I want and not feel like I have to look over my shoulders. And I can breathe again.”

In *Evicted*, Matthew Desmond says “America is supposed to be a place where you can better yourself, your family, and your community. But this is only possible if you have a stable home.” At JFS, we believe that stable and secure housing is the foundation for well-being for all people – regardless of income, race, age, faith, or disability. We know that increasing safe and affordable housing is critical, and we appreciate your support in making it a reality for more people in our community.

Volunteers Make a Difference Everyday

In 2017, Jewish Family Services (JFS) served over 2,000 individuals with the help of over 700 volunteers. Volunteers helped clients and the agency in each of our departments, including the JFS and the JFS Housing, Inc. Boards of Directors. Volunteers served on-site, in community rooms, in the field, at client's homes and at their own homes or places of employment.

Following are some of the ways that JFS volunteers enhance the work that we do:

- Help older adults learn and practice English in English as a Second Language classes
- Aid people's access to food security at Mobile Food Pantries and for Emergency Food needs
- Provide companionship to isolated older adults as Friendly Visitors
- Offer socialization opportunities to adult and senior clients through games, arts and crafts activities
- Enrich resident social experiences and build community at seasonal and holiday celebrations at our housing community
- Support client social skill development at Sandy Naimon Breakfast Club gatherings
- Increase work capacity in agency IT, HR and the Development department
- Expand literacy opportunities for children and youth
- Provide warmth in winter to individuals and families with handmade scarves and hats
- Manage collection of in-kind donations and drive items
- Support the smooth flow of agency events
- Maintain holiday traditions for those who would otherwise not be able to coordinate various holiday gatherings
- Guide the Volunteer Service Program as Advisory Committee members



A Path to Healing: Counseling Services for Survivors of Sexual Assault and Trauma

Jewish Family Services' (JFS) outpatient mental health clinic continues to play a pivotal role in offering a path to healing for survivors of sexual assault and trauma through our practice located at the Sojourner Family Peace Center. In our first year of service with a single therapist, we provided over 900 counseling sessions and with the addition of a second clinician in 2017, we plan to nearly double the number of sessions offered. Despite increased awareness and utilization of our services, experiences of sexual assault and personal trauma remain hidden in our society. One of the biggest misconceptions about intimate partner violence is that it occurs less frequently than statistics show. The Centers for Disease Control statistics on Intimate Partner Violence (IPV) state that nationally one in four women and one in seven men will experience IPV in their lifetime, and worldwide those numbers are even higher.

Our clinicians describe that, across the board, survivors of trauma take on so much more responsibility for what has happened to them and this is even more so with regard to intimate partner abuse. Clients somehow take on the shame of what happened to them instead of directing that shame towards the individual who abused them. They themselves believe they somehow were complicit in being abused. And our society does a great deal of victim blaming (*Why didn't you leave? Why did you go to that club? What were you thinking?*) So why would a person acknowledge intimate partner abuse?

What most people don't realize is that Intimate Partner Violence (IPV) is traumatic and impacts all aspects of a survivor's life- physical, emotional, financial, spiritual, and relationships with others.

More education is needed to help law enforcement and medical providers who come in contact with a survivor to better understand the way the brain experiences and survives trauma. When a sexual assault or personal trauma happens, the survivor's brain response may not yield an accurate memory full of details, timelines, place, people, etc. Because they are unable to provide a complete narrative, the survivor is often demeaned for not having collected sufficient information for an arrest.

Our clinicians share that it takes tremendous courage for survivors to speak out about what has happened to them. Speaking out is transformative in shifting blame away from the victim and onto the abuser. What they need most to heal and recover from their experiences is to be believed and to not be blamed. They also are helped by being seen as courageous and resilient; as a whole person and not as a victim. We know that healing from IPV is possible with trained individuals who can walk with survivors on their path of healing and we are committed to serving those in need in our community.





Assisted Living Services Afford Seniors and Their Families Peace of Mind

For many seniors and their families, the decision to downsize from the family home and move into a supportive setting can be overwhelming. As seniors experience more health and mobility issues, they can become isolated, less independent and don't want to be a burden to their family. Families can struggle to manage their loved one's growing care needs and many are unable to provide care 24 hours a day on a long-term basis. Seniors without proper support services can also suffer dramatic declines in health and well-being due to self-neglect. A 2014 survey of care managers shows that 92% reported self-neglect amongst elders as a significant problem and 52% described it as a significant and growing problem. (NAPGCM, National Association of Professional Geriatric Care Managers, 2014).

Our Deerwood Crossing Senior Residences is a licensed Assisted Living facility that offers seniors and their families' peace of mind knowing that quality support services and assistance with routine daily living needs such as laundry service, housekeeping, help with personal care needs, medication administration, coordination of medical appointments, and transportation are available anytime.

Seniors who receive Assisted Living services don't have to worry about grocery shopping and cooking daily meals because they can have nutritionally balanced meals served to them every day in a spacious dining room. A skilled chef prepares delicious "home-cooked" style meals seven days a week to appeal to a variety of tastes. Family members and friends are welcome to stop by and join their loved one for dinner at any time.

One of the special features of our housing community is our Campus Integration Program that provides no-cost educational sessions, social activities, and social service supports to help residents live safely, independently and to participate fully in our specialized senior community. These activities have taught seniors how to protect themselves from ID theft and fraud and how to prevent falls by taking additional safety precautions. Social events like Italian Bistro and Green Bay Packers themed dinners help seniors build friendships. Community volunteers host bingo and other board games and fun arts and craft activities. We have vans and a bus able to accommodate wheelchairs, walkers and scooters to transport residents to local attractions, concerts, shopping and other entertainment events.

A recent survey of seniors who receive Assisted Living Services reflects that they benefit greatly from these additional supports. One resident remarked, "I think you hired an excellent group of people to run your place - keep up the great job!" We know that Assisted Living Services give residents the opportunity to age in place and not suffer the disruption and loss of friends and relationships caused by moving into a residential setting when their care needs change. We are pleased to offer resources that support the dignity, independence and well-being of seniors.

Bradley Crossing Ground Breaking and Sneak Peek

Because of the generosity of our donors and the success of our 150th Anniversary Capital Campaign, our residents will have even more amenities to enjoy with the completion of our new green space. The half-acre recreation and leisure space is located in the heart of our housing community.

It includes:

- A playground with climbing structures for children of different ages. It has features specifically designed for children with special needs, including a wheelchair accessible swing and a cozy cocoon to help kids with autism spectrum disorders manage sensory stimulation.
- A covered pavilion and picnic area with grills and seating.
- A community garden with raised beds for ready access for persons using walkers, wheelchairs and motorized scooters.
- A walking path for daily exercise.
- A large open space that can be used for multiple group and community activities such as a family movie night, talent shows, soccer, special events and activities.


